## **Personal Information**

### **Who do we disclose your personal information to?**

Your personal information will only be used for stated purposes to assist us in providing the best possible Membership service. We do not rent, sell or trade our membership list.

### **Disclosing your personal information when required or permitted by law:**

We may be required to provide your personal information in response to a search warrant, court order or other legally valid request. We may also disclose your personal information to help us collect a debt owed by you to COSA.

## **Obtaining Your Consent**

At the time of Membership Application you will be required to provide certain personal information. In addition, you will be asked to provide your written consent when you give personal information. You are confirming your consent by completing the Membership Application or returning your Renewal Notice.

### **Withdrawing your consent:**

You may withdraw your consent for the use of your personal information by contacting us at any time.

Legal and other requirements may prevent you from withdrawing consent and your decision to withdraw personal information may also limit the Membership we are able to provide to you.

### **Access to and accuracy of your personal information:**

Upon request we will provide you with access to your personal information as well as provide you with a list of third parties to whom your personal information was provided.

If you wish to change or update your personal information, you may request to do so at any time. Please note that we may only alter that personal information required to fulfill the stated purposes.

### **Where is your personal information kept?**

Your personal information may be kept in electronic or paper format in the offices of COSA and or other designated locations.

### **Protecting Your Information**

Policies, procedures, guidelines, and safeguards have been put in place at to ensure your personal information is protected.

Our employees and service providers have access to your personal information to enable them to perform their duties in servicing you.

Any personal information collected from you will only be used for the purposes identified at the time of collecting the information and will be retained for as long as is necessary to fulfill the service, or as required by law.

### **Complaints**

We are committed to treating you with respect and consideration in all dealings. From time to time however, a misunderstanding or error may occur regarding matters of privacy. In such circumstances, we will act diligently to resolve the problem.
